MCQs CLUB PRIVACY POLICY

Our Privacy Policy is meant to help you understand what information we collect, why we collect the information, what information do you share with us and [how you can update, manage, export, and delete your information](#).

Hey! When you Sign up and use our services, you're trusting us with your information. We understand this is a big responsibility. But hey! don't worry we ensure and work hard to protect your information and put you in control.

Effective May 05, 2019

This Policy describes the information we process to support MCQs CLUB and features offered by MCQs CLUB. You can find additional tools and information in the MCQs CLUB settings.

INFORMATION MCQs CLUB COLLECTS

Understand the types of information we collect as you Sign up and use our services

To provide our services, we must process information about you. You can learn how to access and delete information that we collect by visiting the settings area. The information we collect, and how that information is used, depends on how you use our services and how you manage your privacy controls.

When you're not signed in to a MCQs CLUB Account, we collect non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request.

When you're signed in, we also collect information that we store with your Google Account, which we treat as personal information.

Things that you and others do and provide

When you create a MCQs CLUB Account, you provide us with personal information that includes your name, email address and a password. Even if you aren't signed in to a MCQs CLUB Account, you might choose to provide us with information — like an email address to receive updates about our services.

You can choose to provide information in your MCQs CLUB profile fields or the country you long and links to your other social media accounts. This and other information could be subject to special protections under the laws of your country.

We collect information about how you use our services, such as the types of content that you view or engage with, the features you use, the actions you take, the people or accounts you interact with. For example, we log when you're using and have last used our site.

We also collect potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on our blogs and community forum.

Google Analytics, as a third-party vendor, help us collect information about you which includes unique identifiers, browser type and settings, device type and settings, operating system, mobile network information including carrier name.

The Microsoft Clarity, as a third-party vendor, records information about users who visit our website, and how they behave.

You can visit your MCQs CLUB Account to find and manage activity information that's saved in your account.

WHY MCQs CLUB COLLECTS DATA

How do we use this information?

We use data to build better services

We use data for analytics and measurement to understand how our services are used. For example, we analyze data about your visits to our sites to do things like optimize product design.

We use information we collect, like your email address, to interact with you directly. For example, we may send you a notification if we detect suspicious activity, like an attempt to sign in to your MCQs CLUB Account from an unusual location, we send password reset and account

deletion notification via email. Or we may let you know about upcoming changes or improvements to our services.

We use the information that we have to send you marketing communications, communicate with you about our new products and let you know about our Policies and [Terms](#). We also use your information to respond to you when you [contact us](#).

We use the information that we have to verify accounts and activity, combat harmful conduct, detect and prevent spam and other bad experiences, maintain the integrity of our services, and promote safety and security on and off of MCQs CLUB services. For example, we use data that we have to investigate suspicious activity or violations of our Terms or Policies.

We'll ask for your consent before using your information for a purpose that isn't covered in this Privacy Policy.

We implement a variety of security measures to maintain the safety of your personal information when you enter, submit, or access your personal information.

HOW IS THIS INFORMATION SHARED?

When MCQs CLUB shares your information

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential.

We do not share your personal information with companies, organizations, or individuals outside of MCQs CLUB except in the following cases:

- With your consent
- With domain administrators:

If you're a student or work for an organization that uses MCQs CLUB services, your domain administrator and resellers who manage your account will have access to your MCQs CLUB Account. They may be able to:

- - Access and retain information stored in your account, like your email
 - Change your account password
 - Suspend or terminate your account access
 - Receive your account information in order to satisfy applicable law, regulation, legal process, or enforceable governmental request
 - Restrict your ability to delete or edit your information or your privacy settings
- For legal reasons

Your Public information, as available in your public profile page, can be seen by anyone, including if they don't have an account. This includes your MCQs CLUB username, bio, gender, profile picture, social media accounts.

How can I manage or delete information about me?

We provide you with the ability to access, rectify, port and delete your data.
